Swimming Lane Regulations Gödöllő City and Regional Swimming Pool

1. A spectator may enter the venue of a sporting event if:

- Have a valid pass or other proof of entry;
- Obviously not under the influence of alcohol, drugs or other intoxicating substances;
- Not carrying alcohol, drugs or any other object that endangers the holding of the event or the safety of people or property as well as the possession of which is prohibited by law or the organizer of the sports event;
- Not carrying any signs that incite hatred towards others, flags or totalitarian symbols prohibited by law;
- Is not subject to a ban pursuant to Section 73 § (1) of Act of 2004 on Sport (hereinafter Stv.), a ban on attendance at sporting events, a ban for an offence, or a decision of a foreign sport organization, authority, or court with similar content pursuant to Section 76/A § (1) of the Stv;
- Does not engage in eny conduct pursuant to Section 73 (2) of the Stv. ("the organizer shall require the participant who endangers the holding of the sports event or the personal safety and property of others, or engages in racist, hate-mongering, fear-mongering or offensive conduct, or behavior not related to fair sportsmanship, to stop such conduct").
- Undertake to provide proof of identity when the director requests it;
- Comply with the safety rules set by the organizer, and agree to have their clothing and luggage checked;
- Not engage in, or be likely to engage in, based on past and/or current conduct- any activity that disrupts, interferes with or endangers the physical safety or property of
 participants in, or those arriving at or leaving the sporting event;
- Acknowledges that he/she may be video, and audio recorded during the sporting event;
- Acknowledges that during the sporting event, the organizers will continuously monitor the compliance of the Rules of the track.
- The police officer and organizer providing security for the sports event are authorized to inspect the clothing and luggage of the participants in the sports event.
- 3. Participant may enter the sports facility only trough the entrance gate indicated on the ticket, season ticket or invitation, approach the sector on the designated route and occupy the seat indicated on the ticket/season ticket/invitation. If the spectator fails to comply with this condition or with any request made by the organizer, he will be refused to enter the facility. The spectator may leave the sports facility only unless the organizer agrees otherwise- at the entry point indicated on the ticket.
- 4. Any person who, during a sporting event, enters or remain in an area of the facility that is closed to spectators or a specific group of spectators without authorization or throws into such an area an object that endangers the holding of the sporting event, or the physical safety of others commits an offence. The offender will be detained by the organizers and handed over to the police authorities. Any person who appears or remains at a sporting event with his/her face concealed in such a way as to prevent his/her identification by the authorities or the officials commits an offence. Viewers are reminded to comply with the relevant provisions of Act XLII of 1999 on the Protection of Non-Smokers and certain rules for the Consumption and Distribution of Tobacco Products.

5. The spectator at the sports event:

2.

- o must comply with the provisions of the Rules, the regulations laid down by the organizer and the instructions of the organizers;
- abide by the rules on smoking;
- o not engage in any activity that disrupts the order of the sporting event, thwarts, or endangers the safety of persons or property of participants in the sporting event
- engage in racist or hate speech, aggressive behavior or behavior incompatible with fair play;
- place signs, banners and flags which are not under prohibition, on fences, railings or poles only with the permission of the organizer, and cannot cover advertising or escape routes;
- must leave the venue of the sporting event at the time of the end of the event and at the request of the organizer or the police in the case of a situation that threatens the safety
 of people or property;
- o may not engage in any business or current political activity without a formal license.

6. If the spectator does not comply with the Rules of the Rules:

- o violates the Rules of the track or does not cease the offending behavior when requested to do so by the organizer, he/she will be removed from the event;
- In the case of a sporting event organized by the organizer and with the participation of travelling sports organization, when an entry system is used, the organizer is obliged to
 refuse to sell tickets to the person removed from the sporting event and to prevent him/her from participating in the sporting event (hereinafter together referred to as
 "exclusion from participation in the sporting event"). The period of exclusion from participation in a sporting event shall not be less than six months and shall not exceed two
 years in the case of exclusion from all sporting events organized by the organizer or with the participation of the travelling sports organization and four years in the case of
 exclusion from a specific sporting facility;
- If a person applying for entry to a sporting event or a participant does not comply with the conditions set out in Article 73(1) of the Act during the duration of the sporting event or does not cease the conduct referred to in paragraph (2) after being warned by the organizer, he/she shall be refused to enter or removed from the sporting event. The organizer asks the person to prove their identity. If the person fails to comply with this request, the organizer shall, -unless otherwise provided by law-, immediately notify the police to obtain identification. Until the arrival of the police, but not later than the end of the third hour after the notification, the director may detain the person, provided that the detention takes place within the field of vision of operative image recording device. The provisions of § 74 (4) and (5) of the Stv. Contain the relevant provisions to the handling of the recordings made by the image recording device.
- for damages resulting from a breach of the Rules of the Track, the causer, or in the case of multiple participants, the participants are jointly and severally liable according to the
 general rules of the Civil Code on damages. Liability for damages doesn't affect the infringement or criminal liability of the spectator;
- the person who caused the damage shall reimburse to the sports organization, all the costs arising from the damage, given that he/she is liable under the general rules of the Civil Code on damages;
- 7. The spectator must leave the venue of the sports event at the time of the end of the sports event and at the request of the organizer, the director, or the police due to the emergence of a situation that endangers the safety of people and property. In case of a situation endangering the safety of persons and property, the escape route and the method of escape shall be governed by the instructions of the police in charge of the venue, according to the relevant plan drawn up in advance by MATE Sport Nonprofit Kft.

8. To ensure the safe conduct of sporting events, the organizer:

- ensure the documented receipt, safe custody and return to the rightful claimant upon departure of the items that are not to be brought onto the area of the sports facility,
 specified in the Annex to the Rules of the Track. The safe storage of objects taken into custody shall be provided in containers located at the access points. If the owner of the
 objects taken into safe custody does not report within two hours of the end of the sports event, the organizer will proceed according to the rules of responsible custody, but will
 keep the objects for a maximum of two weeks;
- has the right to prohibit the entry of objects that do not belong in the sports facility, or are not appropriate for the event (e.g. umbrellas, deodorant, plastic bottles, glass bottles, tools, food, vehicles, etc.), other living creatures (e.g. pets) and to have this checked through the organizers;
- have the right to observe the sports event in the venue, at the entry points, in the public areas of the sports facility and in the designated parking areas, with a camera that allows the individual identification of the participants, and to observe and record the recording with a camera of a quality that allows the individual identification of the participants, fixed on the body of the organizer or, if a director is employed, of the director.
- The participant of the sports event will be informed about the conditions of entry, the method of control and the possibility of removal by means of clearly visible, updated notices, including pictograms, in Hungarian, English, German and the language of the country of the foreign visiting sports organization, outside and on the territory of the sports facility.

9. The organizer has taken out liability insurance for the participants.

- 10. In order to ensure the safe departure of participants, the police may detain a specific group of spectators in the sports facility. If the police are not present at the sporting event, the organizer may decide to detain the spectators independently.
- 11. The detailed requirements for the safety of the sporting event and spectators and other participants shall be laid down by law.
- 12. A spectator who directly or indirectly violates the relevant legislation, the rules of the track or the interests of MATE Sportcentrum may be removed from the match, banned from the event in case of a violation, banned in case of a penalty, and may be excluded by the sports organization according to § 73 of the Stv.
- 13. Attention, there is video and audio recording in the facility! Area monitored by camera!
